

## **PRIVACY POLICY**

### **Introduction**

We do our best to protect the privacy and security of your personal data that we process or manage. The Privacy Policy describes our privacy practices regarding our interactions with you online, over the phone, or when you visit our office with video surveillance installed.

Personal data in the meaning of this Privacy Policy is information or a set of information about an individual who is identified or can be specifically identified.

By using our website located at: <https://2021.vintage.com.ua> and receiving services from us, you agree and grant us permission to collect, register, accumulate, store, adapt, modify, renew, use, distribute, depersonalize and destruct personal data, including using information systems in the manner determined in this Privacy Policy.

You hereby confirm that you have full legal capacity under the laws of your country to consent to this Privacy Policy and consent to the processing of your personal data on the terms set out here. In the event that you do not have sufficient legal capacity, you confirm that consent to these rules has been provided by your parents or legal representatives who have full civil legal capacity and are authorized by the laws of the country of your jurisdiction to give such consent.

You hereby consent to the processing of your personal data and confirm that you are aware of the procedure and purpose, as well as other terms for their processing in accordance with articles 6, 8, 10, 11 of the Law of Ukraine "On the Protection of Personal Data".

All amended terms and conditions automatically come into force from the date specified in the Privacy Policy, unless otherwise specified.

### **Scope of the Privacy Policy**

This Privacy Policy applies to this website and the personal data of individuals (customers, suppliers and business partners of our company, etc.). Our website may contain links to third-party websites for your convenience and information. By clicking on these links, you leave our website. We do not control third-party websites or their privacy practices, which may differ from ours. This Privacy Policy does not apply to personal information that you provide to third parties that are not associated with us. We do not track or control the information that is collected on these websites or the privacy practices of any third-party websites and are not responsible for the procedures or content of such websites.

### **Types of information we collect and use**

Our website uses various interfaces (if provided by the functionality of the website), which allows you to request information about our services, through electronic request forms, telephone inquiries, and using social networks (messengers). Contact information can be requested every time. This information is used to enable us to provide answers to your inquiries.

If you visit our office with video surveillance systems installed, your movements may be recorded.

We undertake to collect, use, transfer or process personal data only for the purposes for which it was collected. We may also use the data for other related purposes indicated below.

## **What we do with the information we collect**

In order for you to be able to receive the services, we will request some information from you that will be used to contact you. You will need to provide contact information (e.g. name, email address, phone number). The contact information received from you is used solely for the purpose of establishing contact with you to provide the services.

We may also process or disclose your personal information collected by us in order to comply with applicable legal requirements, industry standards, and our Policy. We may process or disclose your information in situations when we try to prevent, investigate and respond to fraud, unauthorized access to or use of our services, breaches of our Terms & Conditions, and this Policy, and other wrongful, illegal or inappropriate behavior.

## **Rights of subjects of personal data**

The subject of personal data in the understanding of this Privacy Policy is an individual in respect of whom, in accordance with the law personal data is processed.

Personal non-property rights to personal data belonging to each individual are inalienable and inviolable.

The personal data subject has the right:

- to know about the sources of collection, the location of personal data, the purpose of their processing, the location or place of residence (stay) of the owner of personal data or give an appropriate order to receive this information to persons authorized by him, except as otherwise provided by law;
- to receive information about the terms for providing access to personal data, including information about third parties to whom his personal data is transferred;
- to access your personal data;
- receive, no later than 30 (thirty) calendar days from the date of receipt of the request, except as otherwise provided by law, an answer on whether his personal data is being processed, and also receive the content of such personal data;
- to submit a reasoned request to the owner of personal data an objection to the processing of their personal data;
- to submit a reasoned demand to change or destroy your personal data by any owner of personal data, if these data are processed illegally or are unreliable;
- to protect their personal data from illegal processing and accidental loss, destruction, damage due to intentional concealment, failure to provide or untimely provision of them, as well as to protect against the provision of information that is inaccurate or defaming the honor, dignity, and business reputation of an individual;
- to submit complaints about the processing of your personal data to the Human Rights Commissioner of the Verkhovna Rada of Ukraine or the court;
- to apply remedies in case of violation of legislation on the protection of personal data;
- to withdraw consent to the processing of personal data;
- to know the mechanism of automatic processing of personal data;
- to be protected from an automated solution that has legal implications for it.

## **Electronic communication**

After you send us a request, we may contact you by email, phone, or using social networks (messaging) and will make every effort to comply with your preferences. For more information on the purposes and scope of data collection and processing in connection with the peculiarities of communication through social networks (messaging), please visit the privacy policy of the subjects who provide these opportunities.

According to your marketing preferences, we may send you information about our new products, services, special offers, and general information.

We will send you messages related to our services that are not related to marketing when the need arises.

## **Security**

We do not guarantee the security of our servers, and also that the information that you transmit to the site cannot be intercepted during transmission over the Internet or other means. We adhere to general industry standards to protect the personal information provided to us during transmission and after receipt.

## **Cookies**

We collect information automatically using cookies and other digital markers. Cookies and digital markers are small files that may be stored on your computer's hard drive or embedded on our website that enable us to identify you and track your visits to the website. We may also use the services of third parties to collect and process personal data using cookies and other digital markers on our behalf.

There are two types of cookies we use: session cookies (i.e., cookies exist only during one online session on a website) and persistent cookies (i.e., cookies are saved on your computer after you have closed the browser or shut down your computer).

In some circumstances, we may engage third parties to track and analyze personal and non-personal information.
